## **2021 VOLUNTEER PARTICIPATION (Please Read and Initial)**

The LONG VALLEY RAIDERS FOOTBALL ASSOCIATION (LVRFA) is a volunteer organization that receives no financial assistance from the town. In order to field the teams, pay for approximately \$400 worth of equipment per player and other costs such as lighting, field use fees, practice equipment, etc., the Raiders rely on the participation of all parents/guardians to give the children the chance to participate in football. We ask all parents/guardians to help make this year successful. Each level will be assigned a responsibility. The responsibility for each level will be determined by the board after registration has ended. **Each family will be assigned a date and time to volunteer. This will be painting the fields, working the concession stand or selling apparel.**

**Please be advised that your bond check will be cashed if:**

- 1. The required number of volunteer hours (4 hours per child) is not fulfilled.**
- 2. Equipment is not returned. In addition to cashing the bond check for not returning the equipment provided to each child, the family will be billed an additional \$250 to pay for the balance of the cost of the equipment not returned (per child).**

**Note: If volunteer hours are not fulfilled and equipment is not returned the bond check will be cashed and the family will be billed \$400 for each set of equipment not returned to the program.**

We also ask for your participation in an additional organization activity. You may be called upon to volunteer in the event that there is a need for additional help.
